## Scale of fees 2021 - Cruise.

### Arrival fee:

NOK 0,16 pr. GT

### Berthing fee:

For the first	5000	GT	NOK 0,65 pr. GT
For the next	25000	GT	NOK 0,59 pr. GT
For the next	120000	GT	NOK 0,66 pr. GT
For the next	50000	GT	NOK 0,58 pr. GT
Above	200000	GT	NOK 0,56 pr. GT

The berthing fee is payable pr. commenced 24 hrs. docking time.

### **Cancelation fee:**

18 month prior to ETA:	15% of the berthing fee to be paid.
12 month prior to ETA:	30% of the berthing fee to be paid.
6 month prior to ETA:	40% of the berthing fee to be paid.
48 hrs. prior to ETA:	50% of the berthing fee to be paid.
24 hrs. prior to ETA:	100% of the berthing fee to be paid.

Direct costs relating to a cancelation will be invoiced.

**Tender fee:** NOK 10.50 per passenger.

**Pax fee:** NOK 10,50 per passenger.

**Security fee incl. PFSO:** NOK 10,80 per passenger. Minimum NOK 5000,-

Coach companies to pay a fee of NOK 300, - for each departure from the parking area.  
Other parties will be in need of agreement with Nordfjord Havn IKS to use the parking area.

Mooring fee: 0-5000 bt: 0,42 5001-15 000 bt: 0,32 15 000 bt and up: 0,22 (Min.NOK 3000,-)  
Infrastructure (buoy)fee: 0-5000 bt 0,21 5001-15000 bt: 0,14 15001 bt and up: 0,09  
(Min. NOK 1500,-)

Freshwater: NOK 16, - per ton. / Infrastructure fee NOK 3, - per ton.

### **EPI (environmental incentive)**

EPI includes the following: Dock fee, use of tender jetty, pax fee and Security/ISPS.

Ships using LNG, hydrogen or battery will receive max EPI score: -14% for all the above-mentioned regulations. Otherwise, the following applies:

Score under 30:

$((30 - \text{EPI score}) \times 2/100) \times 100\% = \% \text{ increase to the above regulations.}$

Score above 30:

$((30 - \text{EPI score}) / (6 \times \text{EPI score})) \times 100\% = \% \text{ decrease to the above regulations.}$
